

## LIONS TOUR AUSTRALIA 2025 PRIORITY ACCESS PASS WEEK ONE COMPETITION

Each PAP purchased for the Tour will count as one entry into the prize draw to win the Signed Jersey.

### PLEASE NOTE

The Signed Jersey can only be posted to registered addresses in the United Kingdom and will be sent by standard post. Given the package size, someone will need to be at the address to take receipt.

2. This competition is open to Tour PAP purchasers resident in the United Kingdom only. Employees, friends and relatives, and associated third-party suppliers of Lions Rugby Travel or the British & Irish Lions DAC are not permitted to enter the competition.
3. The Promoter may refuse entries at its discretion if they appear to be dishonest, defective, in breach of the rules, forged or in bad faith.
