1. There will be ten winners who will receive a Cap. This competition will run from 00:00 on the 23 August 2021 to 23:59 on the 05 September 2021.
2. This competition is open to Tour PAP purchasers resident in the United Kingdom only. Employees, friends and relatives, and associated third-party suppliers of Lions Rugby Travel or the British & Irish Lions DAC are not permitted to enter the competition.
3. The Promoter may refuse entries at its discretion if they appear to be dishonest, defective, in breach of the rules, forged or in bad faith.
