

## LIONS TOUR AUSTRALIA 2025 PRIORITY ACCESS PASS ROUND THREE COMPETITION

2. This competition is open to Tour PAP purchasers resident in the United Kingdom only. Employees, friends and relatives, and associated third-party suppliers of Lions Rugby Travel or the British & Irish Lions DAC are not permitted to enter the competition.
3. The Promoter may refuse entries at its discretion if they appear to be dishonest, defective, in breach of the rules, forged or in bad faith.
