TERMS & CONDITIONS - LIONS TOUR AUSTRALIA 2025 PRIORITY ACCESS PASS COMPETITION

1. There will be one winner who will receive the Prize. This competition will run from 0000 hrs 23 February 2023 until 2359 hrs 31 March 2023.
2. This competition is open to residents of the United Kingdom over 18 years of age. Employees, friends and relatives, and associated third-party suppliers of LRT are not permitted to enter the competition.
3. Entrants must purchase a LRT Priority Access Pass for the Australia 2025 tour between 0000 hrs 23 February 2023 and 2359 hrs on the 31 March 2023.
4. There is one entry into the Prize draw per Priority Access Pass purchase.
5. Priority Access Pass Terms and Conditions apply to the purchase of each Priority Access Pass and can be viewed during the purchase process or at <https://www.lionstour.com/terms-and-conditions/>.
6. LRT may refuse entries at its discretion if they appear to be dishonest, defective, in breach of the rules, forged or in bad faith.
